Subject: Driving Dressage Tests Modification Policy

Dear Manuel & Károly,

An athletes meeting was held at CHIO Aachen on Wednesday June 28, 2023. The meeting was well attended and the majority of the competing athletes were present, as well as officials, chefs d'equipe and representatives of national federations. The meeting was hosted by ICDA.

The principal topic of discussion was the publication of the Driving Dressage Tests Modification Policy on June 5, 2023. Those present welcome the principle of having a structure for modification of dressage tests for all classes. However a number of concerns were expressed with regard to the process and the content of this proposal.

In earlier discussions with representatives of the Driving Technical Committee it was clearly understood that athletes were to be chosen automatically from the top-5 of the FEI World rankings in descending order, creating confidence in the process of developing new dressage tests. This applies to all classes and all athletes.

The current rules provide for 100x40 meter arenas for driving championships (in combination with a choice for OCs by 80x40 or 100x40 meter arena for other competitions). The proposed policy commits the working groups solely to design for a 80x40 meter arena. Although at the meeting only one athlete was open to discussing regarding to an 80x40 meter arena, the majority of those present at the meeting clearly believe that the 100x40 meters is the most appropriate for four-in-hands of horses,. Secondly the proposed time table only works if the is a rule change before the introduction of the test after the World Championships in 2024. As this implies a major rule change, it is our understanding that this cannot be introduced before 2026 and therefore would not meet the 2-year qualification period conditions required for new tests before a world championship.

Our proposal is:

- 1. To put on hold the application process for applications from athletes.
- 2. A revised selection procedure needs to be agreed in line with earlier discussions with FEI representatives to ensure that athletes either the top level athletes (starting with the top 5 and not the suggested top 20) in dressage and/or world ranking are part of the working group.
- 3. Terms of reference have to be agreed up front, specifically the 3* test has to comply with the current rules for 100x40 arenas for driving championships. The 2* and 3* tests need to work for both 100x40 and 80x40 arenas, therefore meeting the requirements for both four-in-hand classes (horses and ponies).
- 4. ICDA proposes to recommend athletes to become members of the different working groups.
