Proposed Wording

Children: Category of Athletes who may take part in FEI "Children" Competitions. Inclusion of Athletes in this category takes place from the year they reach the age of twelve (12) until the end of the year they reach the age of fourteen (14). For Driving the minimum age is ten (10).

U25: Athletes may compete in the U25 category from the beginning of the calendar year in which they reach the age of sixteen (16) until the end of the calendar year in which they reach the age of twenty five (25). For Driving the minimum age is eighteen (18).

Young Rider: category of Athletes who may take part in FEI Competitions for Young Riders from the beginning of the year they reach the age of sixteen (16) until the end of the year they reach the age of twenty one (21). For Driving the minimum age is fourteen (14 - Horse Single and Ponies).
